**UTAH AUTO SUPPLEMENT – PIP COVERAGE, WAIVER OF LOSS OF INCOME**  
**BENEFITS**

This filing is replacing or modifying a previous released form with edition date 2020/03.

1. "You may choose to waive Loss of Income Benefits if the following state regarding".  
Language to make it clearer.
2. Additionally, the form stated:  
Within the past 31 days of applying for coverage, neither I nor my spouse receive any earned income from regular employment and for at least 180 days from the date of the policy is effective, neither I nor my spouse will received earned income from regular employment

"Receive" in both instances was changed to received in the first instance and receive in the second instance.

The form was filed and approved by Utah.

## **AUTO ID CARDS: NEW FORMATS “SINGLE” AND DIGITAL**

ACORD's forms library includes the ACORD 50 Forms and other state specific forms to be used as proof of auto insurance coverage. These auto insurance identification cards are commonly referred to as auto ID cards.

This month, ACORD's auto ID cards are being released in two new formats: **Single and Digital**.

The **Single** versions of the file are designed so that a Producer/Agent could print up one state specific auto identification/auto insurance card, front and back, as a replacement card or for any other use.

**Digital** versions are designed so that a single completed card could be electronically delivered or saved. For instance, these digital versions could be delivered electronically to an insured.

ACORD's release of the auto ID cards in these formats should not be construed as a relaxation of any state requirements, including any requirements concerning the number of paper cards an insured is to be given or whether a paper card requires a watermark. Additionally, whether an insured can use a **Digital** version as proof of insurance after an accident or traffic stop depends on each state's law.

These new formats attached have been added to our eForms folder on the ACORD forms portal and offered to program participants and memberships with access to the eForms folder.

**No changes to the static text of the Auto ID cards have been made.**
