1. ACORD 660 (2020/12)
INSURANCE AGENT (PRODUCER) DISCLOSURE FOR ANNUITIES

This form is based on the NAIC Model Rule #275 "Suitability in Annuity Transactions Model Regulation", Appendix A.

At present, Arizona and Iowa have adopted legislation this form. For Arizona the effective date of the applicable legislation is December 21, 2020 (SB 1557), see Arizona Revised Statutes: 20-1243.03. For Iowa, the effective date of the legislation is January 1, 2021. See Iowa Administrative Code, 191—15.75(507B).

2. ACORD 960 ID (2020/10)
IDAHO ANNUITY DISCLOSURE

As a result of Idaho H526 and the Iowa Department of Insurance's Bulletin No. 20-11, (release of Form ID AN 2020 (6-19)), ACORD has added this annuity disclosure form to its library. The form is to be used on or after October 1, 2020. As per the Iowa Department of Insurance, the form shall apply to all group and individual annuity contracts and certificates that are subject to the referenced provisions of Idaho Code. The bulletin and Iowa form only applies to policies subject to 41-1941 where not excluded by 41-1941(2).

Note that §41-1941 exempts the following:

- (a) Registered or nonregistered variable annuities or other registered products;
- (b) Immediate and deferred annuities that contain no nonguaranteed elements;
- (c) Annuities used to fund employee pension plans and plans described in section 401(a), 401(5) or 403(b) of the IRS Code and certain other annuities;
- (d) Structured Settlement Annuities.

Therefore, the form exempts the above. Please consult the applicable legislation, Idaho Code §§ 41-1941, 41-1942, and 41-1943, Iowa Department of Insurance's Bulletin No. 20-11 for guidance.
