The Florida Homeowner Application, is used in the underwriting process for Florida's homeowners line of business. This form was filed and approved with Florida's Office of Insurance Regulation.

2. ACORD 610 FL (2021/06) FLORIDA PREMIUM PAYMENT SUPPLEMENT

ACORD 610 FL, Florida Premium Payment Supplement, is a supplement to ACORD 80 FL, to authorize and record pertinent information relating to premium payments involving bank transfers, payroll deductions, credit card deductions, and similar transactions. This form was filed and approved with Florida's Office of Insurance Regulation.

CALIFORNIA FAIR PLAN CLEARNINGHOUSE AND MAY BE THE BASIS FOR ANY POLICY ISSURANCE AND THE ACCEPTANCE BY CLEARNINGHOUSE PARTICIPATING INSURERS."
