1. **ACORD 67 TX (2021/11)**
Texas Homeowners and Personal Property Supplement: CONSUMER BILL OF RIGHTS – Homeowners, Dwelling and Renters Insurance

ACORD 67 TX was changed to comply with recent updates to Texas 28 TAC § 5.9970.

The Bill of Rights was changed significantly. Treat this as a new form. This form represents the 2021 adoption by the Texas Department of Insurance of the “Consumer Bill of Rights Homeowners, Dwelling and Renters Insurance” and the Spanish language translation. 28 TAC 5.9970. (The Spanish version of the form is ACORD 68 TX).

2. **ACORD 68 TX (2021/11)**
Texas Homeowners and Personal Property Supplement: CONSUMER BILL OF RIGHTS – Homeowners, Dwelling and Renters Insurance (Spanish Version)

As with ACORD 67 TX, this form ACORD 68 TX was changed based on Texas 28 TAC §5.9970. This form must be given upon request. See the Explanation of Changes for ACORD 67 TX for additional information.

Note: ACORD 60 TX (Texas Auto Supplement – CONSUMER BILL OF RIGHTS – Personal Automobile Insurance and 62 TX (Texas Auto Supplement – CONSUMER BILL OF RIGHTS – Personal Automobile Insurance (Spanish Version) were previously released in June 2021’s form release.
