# June 2020 EXPLANATION OF CHANGES P&C FORMS

#### **State Specific**

#### **New forms**

1. ACORD 65 SC (2020/08)
SOUTH CAROLINA AUTO SUPPLEMENT
OFFER OF ADDITIONAL UNINSURED MOTORIST COVERAGE AND OPTIONAL
UNDERINSURED MOTORIST COVERAGE FOR COMMERCIAL/BUSINESS

ACORD 65 SC was created to comply with South Carolina's requirement to offer additional uninsured motorist coverage and underinsured motorist coverage. This requirement applies to personal **and** commercial/business lines. S.C. Code § 38-77-350 requires the Director to "approve a form which automobile insurers shall use in offering optional coverages required to be offered pursuant to law to applicants for automobile insurance policies."

ACORD 65 SC was prepared utilizing the language set forth in South Carolina Department of Insurance Form Number 2006. For reference, 61 SC is for personal lines.

This form was filed and approved by South Carolina.

SOUTH CAROLNIA GARAGE AND DEALERS

For compliance with S.C. Code §§ 38-77-121 and 38-75-1200, ACORD revised this from as follows:

- 3. Changed Agency to Producer on Page 1.
- 4. Add above the signature line the following:
  THE INSURER CAN CANCEL THIS POLICY FOR WHICH YOU ARE APPLYING
  WITHOUT CAUSE DURING THE FIRST 90 DAYS. THAT IS THE INSURER'S
  CHOICE. AFTER THE FIRST 90 DAYS, THE INSURER CAN ONLY CANCEL THIS
  POLICY FOR REASONS STATED IN THE POLICY.

## CALIFORNIA FAIR PLAN PROPERTY INSURANCE - APPLICATION FOR DWELLING INSURANCE

At the request of the California Fair Plan, ACORD created a new form edition. The following changes were made:

- 1. Changed Edition date to 2020/06 and change copyright date.
- 2. Added item number 6 to the first page as follows:
  - 6. If the total combined coverage limits exceed \$1,500,000, current exterior pictures of the property and an estimate on the cost to rebuild the dwelling in the event of a total loss from a licensed contractor or appraised must be included with the application. The Dwelling Coverage Limit must be equal to or greater than the amount on the estimate.
