#### 1. ACORD 60 TX (2021/11) Texas Auto Supplement – CONSUMER BILL OF RIGHTS – Personal Automobile Insurance

ACORD 60 TX was changed to comply recent updates to Texas 28 TAC § 5.9970. The Bill of Rights was changed significantly. Treat this as a new form. This form represents the 2021 adoption by the Texas Department of Insurance of the "Consumer Bill of Rights Personal Automobile Insurance" and the Spanish language translation. 28 TAC 5.9970. (The Spanish version of the form is ACORD 62 TX).

Note that all insurers writing personal automobile insurance policies must provide with each new policy of personal automobile insurance a copy of the 2021 version of the Auto Bill of Rights. At the consumer's request, the insurer may provide an electronic copy of the Auto Bill of Rights instead of a hard copy. The insurer must provide the Auto Bill of Rights with each renewal notice for personal automobile insurance unless the insurer has previously provided the policyholder with the 2021 version of the Auto Bill of Rights. Insurers must provide the Spanish language version of the 2021 version of the Auto Bill of Rights to any consumer who requests it. Insurers must provide either the English or the Spanish version, if requested of the Auto Bill of Rights beginning November 15, 2021. Before that date, insurers may provide the ACORD 60 TX (2016/03) or this edition (2021/11). Refer to 28 TAC §5.9970 for more information.

#### 2. ACORD 62 TX (2021/11) Texas Auto Supplement – CONSUMER BILL OF RIGHTS – Personal Automobile Insurance (Spanish Version)

As with ACORD 60 TX, this form ACORD 62 TX was changed based on Texas 28 TAC §5.9970. This form must be given upon request. See the Explanation of Changes for ACORD 60 TX for additional information.
