**New Form:**

**1. ACORD 66 VA (2023/07)  
VIRGINIA AUTO SUPPLEMENT**

We are releasing a new form to address the underinsured motorist change of Virginia. We previously released ACORD 61 VA (2023/07), VIRGINIA AUTO SUPPLEMENT as an R2. After some comments regarding this R2, and that there is still time for implementation we are withdrawing this form and releasing: ACORD 66 VA (2023/07).

This form is similar to the ACORD 61 VA without the R2. Note the following change in this form:

I understand by signing this form I have elected to reduce underinsured motorist coverage **for** all insureds on the policy....

(adding “for”)

Please review VA Code Ann. § 38.2-2206 for more information.

We appreciate the feedback on this. We think that resolves versioning discrepancies and simply, follows a better procedure. We will be **withdrawing** ACORD 61 VA.

**Enhancements:**

**ACORD 80 CA (2023/01)**

Enhancements were made to the Acroform, PDF and XFDL formats, enabling Javascript. No changes were made to the static text.

**NY UPDATE:**

We are aware of legislative changes made to New York's Auto law concerning spousal immunity, amending NY INS Law §3420(g). In short, the statute is amended to provide that all auto policies are to include "supplemental spousal liability insurance", unless the insured declines and refuses this insurance.

We are following NY Senate Bill 833 which, in part, amends the effective date of the legislation. The Department of Financial Services has advised ACORD that they are working on a declination form. We are continuing to follow, of course, for its release and any further guidance. In the interim, should you have any questions, please do not hesitate to contact us.
