EXPLANATION OF CHANGES
P&C FORMS

Countrywide

The following new editions were added to ACORD's forms library.

1. ACORD 301 (2022/12)
NATIONAL FLOOD INSURANCE PROGRAM – FLOOD INSURANCE APPLICATION

This form replaces the 2015/04 edition.

This should be treated as a new form because of the number of changes.

This FEMA form is the application for flood insurance coverage from the National Flood Insurance Program for new policies effective on or after 10/1/21. As of the release of this form, the National Flood Insurance Program had manuals with information that may be helpful; review the following for more information:

This form is based on OMB No. 1660-0006 created when FEMA released its updated Risk Rating 2.0: Equity in ACTION (Risk Rating 2.0) edition of the National Flood Insurance Program (NFIP) Flood Insurance Manual.

2. ACORD 304 (2022/12)
NFIP- FLOOD INSURANCE CANCELLATION /NULLIFICATION

This form will replace the 2018/08 edition of the form.

This should be treated as a new form.

ACORD 304, National Flood Program Flood Insurance Cancellation/ Nullification Form, was created for the National Flood Insurance Program. It may be used to request cancellation of a flood insurance policy. Instructions for completing this form are contained in the NFIP's Flood Insurance Manual. These changes were required to update errors on XFDL formats causing spacing and label issues on the questions about dogs on the premises.

Update:

Because of several regulatory changes, we are adding this section to our Form Notifications so that our membership can be advised of certain matters.

California:

As we have previously advised, California passed legislation that had an impact to California insurance applications and ACORD forms. We anticipate making the changes to the ACORD California and state-specific forms to be compliant with any changes and interpretations to Section 1871.2 of the Insurance Code and expect form changes to be made shortly. A mid-month deployment is being considered. Please reach out with any questions.

Illinois:

Changes in the law require Uninsured Motorists property damage coverage to be offered starting January 2023. Any form changes will need to be approved and filed. This is presently being worked on.

Arizona:

Changes will be made to the Homeowner Application and Mobile Home related to dog breeds. Review 2022 Arizona House Bill No. 2323 for additional information. The act applies to new policies of insurance and renewed policies of insurance issued from and after June 30, 2023.
